A MESSAGE OF GRATITUDE FROM OUR CO-PRESIDENTS

Dear Impact Members, Thank you to each and every one of you for making 2024 another impactful year! Together, we were able to fund another three grants of \$100,000 each to provide housing and supportive services to young people between the ages of 18-24 years old who are experiencing homelessness; transform the lives of first-generation Americans, immigrant students, and children of immigrants by empowering them to pursue higher education; and increase women's access to emergency shelter and stable housing. We also provided Mission Awards to the five runner-up nonprofits thereby recognizing the hard work of all of our finalists. This brought our total funding to date to \$3.24 million to 43 nonprofit organizations!



We continue to evolve and refine our grantmaking in partnership with the nonprofit and philanthropic sector, and were thrilled to pilot Ignite, a new grants program dedicated to supporting grassroots nonprofits with annual budgets of under \$100k (and who therefore do not qualify as a sole applicant for our current Core grants process). This development was very well received by the community and we are grateful to our members for the opportunity to extend the reach and impact of our grant funding to assist the underserved populations supported by four phenomenal nonprofits, highlighted later in this report.

As always, thank you for being part of our giving circle! We hope you feel inspired by this Annual Report and by the collective impact we're making together for those in need throughout our community.

Our ongoing commitment to DEI continues to evolve and our newly named ECE Committee was primarily focused on the launch of our Ignite grant program for small, grassroots nonprofits. Our team researched trends in giving circles — including other Impact100 groups nationwide — and promulgated suggestions and recommendations to the Ignite Task Force resulting in our successful pilot program for Ignite. The committee continued in its support of previously implemented operational components of our giving circle such as updating the inclusion planning calendar and making all members feel welcome including scholarship and sponsorship members.

2024 CORE GRANT RECIPIENTS



American Friends Service Committee: *Breaking Barriers To College For Immigrant Students*

The Need: Immigrant students face systemic barriers that prevent them from accessing and completing higher education.

Program: Empowers students and families to successfully navigate the path to college through personalized mentorship and practical support. Students receive step-by-step guidance on completing college and financial aid applications, while parents are actively engaged through workshops that demystify the process.

Impact: New Jersey's first multilingual college access website — a vital resource for students, parents, and educators seeking clear, culturally responsive information on how to pursue higher education.

Mission Statement: AFSC works for a just, peaceful, and sustainable world free of violence, inequality, and oppression.



Trinity Center For Community: *Empowering Women to Find Shelter and Self-Sufficiency*

The Need: Homelessness is rising among women due to domestic violence, lack of affordable housing, and gendered wealth disparities.

Program: Expands services at Trinity's Code Blue Warming Center through the Radical Well-being Holistic Housing Program. Provides women with housing funds, mental health and recovery support, job training and employment opportunities, and mentoring to strengthen interpersonal and financial skills.

Impact: Stable housing for at least 60 women per year for the next two years. Helping these women to not only find a home but put them on the path to self-sufficiency.

Mission and Vision: For 35 years, Trinity Church has offered refuge to our neighbors experiencing hunger and homelessness. Center for Community expands that work, combining housing support with holistic, individualized resources to help clients.



Covenant House: *Preventing Homelessness after Foster Care*

The Need: Too many young people age out of the foster care system without a stable place to live, a reliable support system, or the resources needed to transition successfully into adulthood. Without targeted assistance, many will be at risk for homelessness.

Program: The Monmouth County Foster Youth to Independence Services Program helps young adults who have aged out of the foster care system and are eligible to obtain a three-year housing voucher. The program helps navigate the process, including completing housing authority applications and securing required documentation to be issued the housing voucher.

Impact: Helping 50 former foster youth secure stable housing and build independence.

Mission Statement: Helping Youth Facing Homelessness and Human Trafficking Survivors

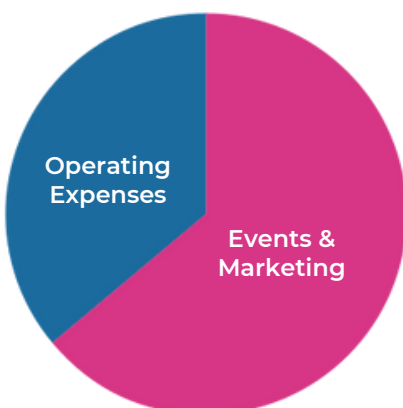
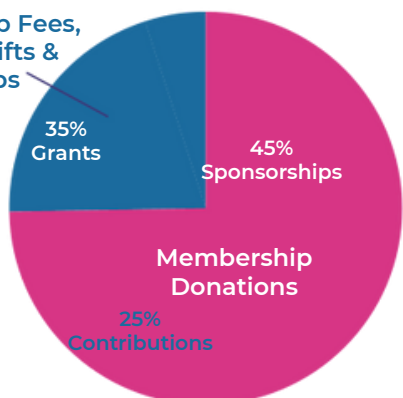
