Purpose

Information We Collect:

Non-Personally Identifiable Information

We collect non-personally identifiable information (non-PII) that web browsers and servers typically make available, such as IP address, browser type, operating system, and pages visited. Personally Identifiable Information

We collect personally identifiable information (PII) when you choose to engage with Impact 100 Jersey Coast through certain activities and provide your information. Examples include:

- **Event Participation**: Information provided when registering for or attending in-person or virtual events or training.
- Contacting Us: When you contact us directly via email, phone, or website.

We use the information collected to:

- Send newsletters, event invitations, and updates related to Impact 100 Jersey Coast.
- Process event registrations and send related confirmations, reminders and follow ups.
- Comply with legal requirements, such as tax regulations for donations and financial reporting.
- Operate and maintain the Website and improve Website functionality.
- Respond to inquiries and requests.
- Maintain our member directory.
